Sealed bids will be received at the office of Rogue Valley Sewer Services (RVSS), 138 West Vilas Road, Central Point, Oregon 97502, until but not after **2:15 p.m. Pacific Daylight Savings Time on Tuesday, March 7th, 2023**, at which time the bid period will be closed. Bids will be publicly opened immediately after the bid period is closed, and read aloud.

A voluntary pre-bid meeting will be held at the RVSS office at 138 West Vilas Road, Central Point, Oregon 97502, on **Tuesday, February 28th, at 2:00 p.m.** The meeting will be followed by a field visit for interested parties to the project site. Statements made by RVSS representatives at the pre-bid meeting are not binding unless confirmed by a written addendum.

The construction of 1,355 feet of 8 inch sanitary sewer pipe along with the associated manholes, reconnection of existing services, abandonment of existing sanitary sewer system.

Contract Documents for this project can be examined at the RVSS office and will be made available for purchase in both Digital and Paper format.

Bids shall be made on the forms purchased from RVSS or QuestCDN.com and addressed and mailed or delivered to the Manager of RVSS in a sealed envelope plainly marked "**Vilas Road Siphon Abandonment, Project No. J343**" and bearing the name and address of the Bidder.

A surety bond or cashier's check or certified check of the Bidder payable to RVSS in the amount of Ten Percent (10%) of the bid must accompany each bid as security.

No bid shall be received from any Bidder who has not been pre-qualified by RVSS pursuant to RVSS Resolution No. 76-5 and ORS 279C.430 within the last twenty four (24) months.

No bid shall be received from any bidder who: 1) is not registered with the Construction Contractors Board; 2) has not provided a statement as to whether the bidder is a resident bidder as defined in ORS 279A.120; and 3) has not provided a statement that the provisions of ORS 279C.840 shall be complied with.

First-Tier Subcontractor disclosure must be included with the bid package at the time of bid closing or in a separate envelope within two working hours after the bid closing, in accordance with ORS 279.02(3).

RVSS may reject any bid not in compliance with prescribed public bidding procedures and requirements and may reject bids and waive any informalities if in the public interest to do so.
